Debits of \$1,421.93 consisted of water & electric bills, PO Box 1 yr rental, website domains for 1 yr, stamps, pool upgrades for inspection, Labor day party supplies, and Paschall pool care from 08-01 to 08-31, leaving a balance of \$7,063.07. Aug 2016 bank balance was \$7,148.67. The report was approved and accepted.

Finance and Planning Committee: The POA Elections meeting will be 11-14-17, which means ballots must be mailed by 10-20-17. A reminder to those who want to be on the ballot must let me know on or before the next meeting on Oct. 10th. The POA has signed up for NNO on Oct. 3rd. We are sponsoring the event with CLUMC as co-sponsor. Ray Gunn and Carol Bissett are coordinating the neighborhood event. Discussion was held regarding the time and place, guest attendees, preparing fliers for the church bulletin, food, music, advertising, and event parking. Our NNO will be held at CLUMC fellowship hall 5:30 to 7:30pm with covered dish and hot dogs. CC Sheriff's Dept, CL Fire Dept, and our County Commissioner are lined up to attend.
